## Nightcare Service Agreement

**THIS AGREEMENT** is entered into by and between Sit! Stay! Play! and \_\_\_\_\_  
\_\_\_\_\_(“Owner”):

1. Owner understands and agrees that Owner is solely responsible for any harm caused by Owner’s dog(s) while Owner’s dog(s) is/are attending Sit! Stay! Play!. \_\_\_\_\_(initials)
2. Owner understands and agrees that during normal dog play, Owner’s dog(s) may sustain injuries. All dog play is carefully monitored by Sit! Stay! Play! to avoid injury, but scratches, punctures, torn ligaments, etc may occur despite the best supervision. \_\_\_\_\_(initials)
3. Owner further understands and agrees that in admitting Owner’s dog(s) to Sit! Stay! Play!, Sit! Stay! Play! has relied on Owner’s representations that Owners’ dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dog. \_\_\_\_\_(initials)
4. Owner further understands and agrees that neither Sit! Stay! Play! nor any of its employees will be liable for any illness, injury, death, and /or escape of Owner’s dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner’s dog(s) attending or participating at Sit! Stay! Play!. \_\_\_\_\_(initials)
5. Owner further understands and agrees that any behavioral or health problems that develop with the Owner’s dog(s) while at Sit! Stay! Play! will be handled and treated as deemed best by the employees and staff of Sit! Stay! Play!, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior. It also includes parasites such as ticks and fleas. \_\_\_\_\_(initials)
6. Owner further understands and agrees that Owner’s dog(s) will at all times while attending Sit! Stay! Play! have current vaccination status. Owner further understands that even if Owner’s dog(s) is vaccinated for Bordetella (Canine Cough) there is a chance that the Owner’s dog(s) can still contract Canine Cough. I agree that I will not hold Sit! Stay! Play! responsible if Owner’s dog(s) contracts Canine Cough. \_\_\_\_\_(initials)
7. Owner further understands and agrees that Owner’s dog(s) may not attend daycare or be boarded if the Owner’s dog(s) is in heat. \_\_\_\_\_(initials)

8. Owner further understands and agrees that Sit! Stay! Play! reserves the right to use a belly band, Gentle Leader™, calming band, Thundershirt™, and/or body wrap. \_\_\_\_ (initials)

9. Owner further understands and agrees that it is the Owner's responsibility to leave an adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog(s) is cared for by Sit! Stay! Play! unless the Owner's dog(s) is being fed the standard diet offered by Sit! Stay! Play!. Should the food/medication supply need replacement, I authorize Sit! Stay! Play! to purchase replacement and Owner will reimburse Sit! Stay! Play! for cost plus a \$35 replacement fee (per occurrence). \_\_\_\_\_ (initials)

10. Owner further understands and agrees that Owner's dog(s) will have access to a fenced outside area. Owner agrees to assume full liability if Owner's dog escapes. \_\_\_\_ (initials)

11. Owner further understands and agrees that if Owner's dog(s) is/are not picked up by the end of the Sit! Stay! Play! regular business day, then Owner hereby expressly authorizes Sit! Stay! Play! to take whatever action is deemed necessary for the continuing care of Owner's dog(s) and Owner agrees and promises to pay to Sit! Stay! Play! all costs of continuing such care upon demand by Sit! Stay! Play!. \_\_\_\_\_ (initials)

12. Owner further understands and expressly agrees that each and every of the foregoing provisions containing in Paragraphs 1 -11 above shall be in force and effect and shall apply to each and every occasion on which Owner boards or deposits Owner's dog(s) with Sit! Stay! Play! for daycare, extended boarding, or training, as the case may be; and that this Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. \_\_\_\_\_ (initials)

Owner hereby certifies that Owner has read and understands these rules and regulations set forth above, and that Owner has read and understands this Agreement, and each of its terms and conditions, and agrees to abide and be bound by these rules and regulations.
